I. Main duties of the research unit in 2012

In 2012 the Institute of Sociology was operating as part of the Centre for Social Sciences, structured into four research department.

The four departments with their highlighted tasks can be summarised as follows:

1) Research Department for Social Inequalities

Main research tasks: social and economic inequalities; the inequalities of opportunities, gender inequalities, research of the sociology of families, minorities, migrants, ageing, young people, poverty, the determinations of social policy and its institutions.

2) Research Department for Knowledge, Values, and Culture

Main research tasks: information- and knowledge-based society, information and communications technology, risk awareness and risk management, non-governmental organisations, political cultures, technology and knowledge economy, research into values, culture and media. The department includes the Voice of the 20th Century Archives, which performs essential public service tasks.

3) Research Department for Integration and Social Changes

Main research tasks: power and social stratification, elites, local governance and local power relations, sustainable consumption, governance and global warming, environment and regional development, development policies, the consequences of EU development policies and projectification, the new system of redistribution, town policies, urban and rural competitiveness, urban and rural development, social changes in cities and rural areas, inequalities and organisations, inequalities in the world of work.

4) Research Department for Theory and Methodology

Main research tasks: the theories and research practices of sociology and interdisciplinary social sciences, sociology of knowledge, social history, community development and active citizenship, human rights, offense and punishment, (public) health and social well-being.

Besides programmes linked to project resources, complementing and summarising them, institute level research cooperation was going on in the following areas:

- the comparative synthesis of values and culture studies,
- the research of old and novel features and dimensions of social reproduction in a new theoretical framework,
- the analysis of the market and redistributional coordination of social redistribution.

The realisation of the major basic research projects of the institute was based on EU and national resources.

An outstanding task of the institute in 2012 was the preparation and publication of the volume of studies on the integration and disintegration processes of Hungarian society.

Another major research area was equal opportunities, dealing with the study of all the essential issues of social policy, and revealing interethnic relations.

II. Remarkable research and other results in 2012

a) Remarkable research and other results

A major outcome of the institute was writing and publishing the volume of studies in December 2012, on the integration and disintegration processes of Hungarian society. The majority of the researchers of the institute contributed to the book with original papers.

Among further research outcomes, the following need to be highlighted:

Research of the growing awareness of rights linked to equal treatment continued, supported by the Office for Equal Treatment (Egyenlő Bánásmód Hatóság), the second collection of data was completed during the year.

An important research project is "The born and unborn children of the system change: the influence of socio-cultural circumstances of birth on demographic processes" (OTKA), a follow-up panel research. The aim of the research is the follow-up of people's and families' lifepaths who had been interviewed 20 years ago, and involving children born at that time in the research. This made it possible for the younger generation of family socialization and background effects in several elections, maternity-related attitudes, and the family was facing young to start a family, child and / or work plans and design.

During the year the AIDS prevention research ISN2 (Budapest Chances) was continued in cooperation with Medical College of Wisconsin CAIR Institute.

Emphasized the continuity of the institutional tasks of domestic violence against men and women in research in Europe, with a background in the theoretical and methodological considerations at home and serve as a model for international comparative work. In 2012 this process continued (Public Health Executive Agency, EU).

The sociology of knowledge in 2012, continued monitoring of the radical analysis.

Value and culture research project at the European Social Survey (ESS) / European Social Survey (EUTE) data analysis as well as the inclusion of the ESS data preparation continued. The plan is a two-way cultural studies following tests were made:

- The role of culture in the public sphere and the functioning of democratic institutions more efficient operation of the system, the society is complex, difficult to understand the processes transparent, active participation in the exploration of possibilities.
- Hungary in the international integration of cultural patterns, changing identities and international participation in the public spaces of the characteristics of research.

Continued in the Voice of the 20th Century Building Archive OTKA grants and new applications, the researchers prepare for enlargement.

The basic research institute took place in the tradition of environmental change, regional development policies, and on the individual and his place of residence influenced the modes of consumption and rural development research. The PROSUITE (EU) research continues twenty-five member consortium: the project demonstrates how technology can be combined with the predictions of the life cycle approach in how to develop and integrate the three dimensions of sustainability. The sustainability of civil society groups and NGOs in project research is based on an intensive cooperation in 2012. Its main objective was to create links between the EU level, civil society and sustainable development among researchers.

During the year ended on Gildan (EU FP7) project, which dealt with issues of household energy use. Important focus was the problem in urban and rural as well as various models of government green policy effectiveness. The research took place in five Member States. The LAG Finnish-Hungarian joint project was completed in 2012, is an English-language edition of the preparation of the volume, which is the subject of one of the most important development in the EU system of comparative analysis. The book will be released in 2013.

The third group of the knowledge and information society, reflected recent phenomena, particularly the elites and the society experienced radicalization.

In the years during which the participating countries, higher education and adult education institutions to analyze factors influencing the practice, as well as two case studies in the Hungarian higher education institutions in adult education activities. The next project is munkaidőrezsimek productivity and working conditions revealed the impact of the context of two case studies. The third project of the global financial and economic crisis on the impact of the supply chain. The project results are summarized in three English-language publications.

The countryside and elite Study Group (EU-FP7) Governance, infrastructure, lifestyle and energy consumption changes during the project: coal, oil, and natural gas-based power generation following years Europe theme analysis, which showed that households make use of the energy produced 35% of household consumption and greenhouse gas emissions caused by 40%. Thanks to the technological innovations appeared in an economical and environmentally-friendly energy production methods. The research examined the population in five European lifestyle, energy consumption habits and consumption patterns. The third aim was to give a picture of the past two decades, the transformation of agriculture, rural society changes. An important result "of integration and disintegration of the Hungarian Society" OTKA project preparation, this book is based on published results. Another three English-language studies on global changes and rural-themed book was published.

The city and environmental sociology research team this year closed a three-year research supported by OTKA, Hungary, the new cities of the social characteristics of the regional development processes, the relationship between urban centers and the surrounding area, revealed conflicts. As a result, it was found that the transition to globalization and the consequences of being a historically evolved traits, and that as a result of modernization

effects to speak of a new urban development model of the organization. The facts are that there are no pure types, and clear answers to the old town with a comparison of the trends of convergence, the differences are indicated. The results are presented in groups of two international conferences, one in English and the volume has been created. The group's work is a result of more recent winners OTKA project that the Central and Eastern European and Hungarian comparisons of new towns, survey to explore the processes of social polarization.

In the year 2012, four researchers received a PhD degree.

b) Dialog between science and society

Both nationally funded projects and international cooperations aim at disseminating the research results at professional forums as well as to the general public. Workshops, press conferences, book launches, media presence, and trainings provided the opportunity to present the research results. Socio.hu, the online critical, scientific journal of the institute published four issues in 2013, available to anyone interested as a forum for social science publications, discussions, and analyses.

The dissemination of research findings among laypeople increased attention in 2012. In addition to radio and other media appearances, as in every year, so last year was included in the "Day of Hungarian Science" event. The Institute staff event, organized by the Scientific Secretary TK.

Most instructors are active researcher, English and Hungarian languages are taught at CEU, Corvinus, the ELTE University of Debrecen, MOME, IBS, the dark, the King James Version university.

Three of them are taught in foreign universities. 18 graduate school in 2012, taught in the Institute.
